Certain qualifications to be eligible to become and remain a Trustee are set forth in the Cooperative Bylaws and Board Policy. In addition, statutory and common law imposes certain duties upon Trustees. This form is to ensure eligibility for consideration by the Nomination Committee as a candidate for election to the WEC Board of Trustees.

**A. Trustee Qualification**

**1. The Code of Regulations Article IV, Section 3, Qualifications states the nominee shall:**

- (a) *Be a member of the Cooperative; and*
- (b) *Be a bona fide permanent resident within the service area of the Cooperative, receiving electric power and energy from the Cooperative at the primary residential abode for a minimum of three years of uninterrupted service; and*
- (c) *Not in any way employed by or financially interested in a competing enterprise or a business selling electric service, power and energy or supplies to the Cooperative;*
- (d) *Not be in any way employed by or financially in control of an enterprise that supplies goods or materials to or performs services for the Cooperative;*
- (e) *Not be a current employee, or is a former employee with less than five (5) years separation from the Cooperative;*
- (f) *Not be a close relative of a current employee or trustee; as used in this section, close relative means through blood, law, or marriage, is a spouse, child, stepchild, father, stepfather, mother, stepmother, brother, stepbrother, half-brother, sister, stepsister, half-sister, grandparent, grandchild, father-in-law, mother-in-law, brother-in-law, sister-in-law, son-in-law, or daughter-in-law; or resides in the same residence;*
- (g) *Abide by all current policies established by the Cooperative;*
- (h) *Not have been sixty (60) days in arrears on any payment or obligation to the Cooperative in the preceding three (3) years;*

- (i) Not have been convicted of any (i) felony, (ii) theft offense, (iii) drug abuse offense, or (iv) any other criminal offense other than minor traffic violations;
- (j) Has not filed for bankruptcy in the past ten (10) years;
- (k) Is fluent in speaking and writing the English language; and
- (l) Be at least eighteen (18) years of age.

**B. Attendance Requirements for Meetings**

A Trustee is responsible for, and must actively participate in, the governance of the business and affairs of the Cooperative. The Board of Trustees of the Cooperative is quite active. It is anticipated that you will spend a minimum of 15 to 24 days, on an annual basis, attending meetings of the Board of Trustees and General Membership, meetings of Affiliated Organizations and Training and Education seminars. **(Please see Exhibit C for a list of meetings)**

**C. Article IV, Section 5. Removal of Board Member**

Cause for Removal

- (a) Failure to attend three (3) regular meetings of the Board during any twelve (12) consecutive meetings, or
- (b) Is convicted, with any right of appeal having been completed, of any (i) felony, (ii) theft offense, or (iii) drug abuse offense not constituting a minor misdemeanor.

**D. Board Policy No. 206 Education/Training**

Each Trustee is required to achieve the Credentialed Cooperative Director (CCD) certification from the National Rural Electric Cooperative Association within two terms (6 years). There are five full day training courses necessary to obtain this certification. Most sessions are held in Columbus however, in order to complete the five courses in a timely manner, out-of-state and overnight travel may be required.
